# School Review Facilitator

The School Review Facilitator's role is to assist the SOC to effectively communicate, collaborate and achieve consensus where possible.

The School Review Facilitator will:

- Facilitate Public Meetings;
- Liaison between SOC and the Board (including information requests);
- Assist the SOC chair when presenting to the elected board; and
- Serve as the SOC chair until the chair is elected.

# How have we arrived at this point?

The Strait Regional School Board approved the following two motions on Wednesday, October 5, 2016:

## **Motion #1:**

- The Strait Regional School Board initiate a review of the Dr. John Hugh Gillis Regional High School Feeder System and that this review will follow the Provincial School Review Policy adopted by the Department of Education and Early Childhood Development for the Province of Nova Scotia.

## **Motion #2:**

- The Strait Regional School Board authorize through the Superintendent of Schools to establish a School Options Committee (SOC) to conduct a review of the Dr. John Hugh Gillis Regional High School Feeder System.

# Guiding Documents

- Provincial School Review Policy (October 17, 2014)

*"The School Review Policy describes the process to be followed by a school board when the permanent closure of a public school is a possibility. The process as outlined in this policy ensures that communities are engaged and informed prior to and at every stage during a school review, and that members of a community are able to contribute to the examination of possible solutions to identified issues."*

*The policy outlines the process through sixteen (16) directives (A-P) along with supporting appendices.*

The Terms of Reference for the Dr. John Hugh Gillis Regional High School Feeder System SOC is contained in the Recommendation to Review document approved by the Strait Regional School Board on October 5, 2016 and adheres to the Provincial School Review Policy.

The SOC will meet regularly (“working meetings”) to consider, create, evaluate and refine solutions to the issues identified in the Recommendation to Review document that meet the review objectives and reference criteria detailed in the Terms of Reference.

At the conclusion of the review the SOC will submit a “Report and Recommendation” to the Strait Regional School Board, through the Superintendent of Schools, for consideration.

# Mandate of the SOC (as outlined in the Terms of Reference)

## **Mandate:**

With the approval of the following motion:

*That the Strait Regional School Board initiate a school review of the Dr. John Hugh Gillis Regional High School Feeder System and that this review will follow the provincial school review policy adopted by the Department of Education and Early Childhood Development for the Province of Nova Scotia.*

# Mandate of the SOC (continued)

The School Options Committee (SOC) will conduct a review of the Dr. John Hugh Gillis Regional High School Feeder System. This review is to consider and make written recommendations to the board respecting the Dr. John Hugh Gillis Regional High School Feeder System.

The review must meet the requirements of the Provincial School Review Policy including:

- conducting a review with public consultation, of the Dr. John Hugh Gillis Regional High School Feeder System as requested by the school board, according to the objectives and within the parameters provided by the board; and
- submitting a Report and Recommendation to the school board which will inform the board's final decision.



# Review Objectives (continued)

## **Review Objectives:**

The objective of the Dr. John Hugh Gillis Regional High School Feeder System school review is to:

- Determine, prior to the decision notice date of April 30, 2017, whether or not Antigonish Education Centre will be required after the lease is up on this P3 building;
- Address the issue of excess space;
- Reorganize the system to optimize the use of school facilities; and
- Create scenarios/options consistent with the objectives and reference criteria identified in the school review process for the Dr. John Hugh Gillis Regional High School Feeder System

# Reference Criteria: Components

- Grade configurations;
- Class size and composition;
- Access to and equity of programming;
- Maximizing use of school facilities;
- Making best use of available resources (financial, labour and capital) across the board; and
- Limiting factors such as transportation time limits, geographically isolated schools.

4. AEC P-4, SACS P-6, SAJS 5-8, Dr. JH Gillis 9-12 - Close HM MacDonald
5. AEC P-4, SAC P-6, SAJS 5-8, New 9-12 to fit population - Close Dr. JH Gillis
6. AEC P-4, HM MacDonald P-6, SAJS 5-8, Dr. JH Gillis 9-12 - Close SACS
7. AEC P-6, HM MacDonald P-6, SACS P-6, Dr. JH Gillis 7-12 - Close SAJS
8. New (P-6) & New High School (7-12) – Close AEC, SAC, HM MacDonald, SAJS, Dr. JH Gillis
